

Terms and Conditions

Reservation And Deposit:

A deposit of \$1500 per person is required at the time of booking to secure your reservation. 50% of full payment by October 15, 2008.

Payments /Cancellation :

- Full Payment is required 45 days prior to departure.
- Cancellations received in writing 45 days or more will be subject to \$250 administrative fee per person.
- Cancellation received less than 45 days and more than 30 days prior to departure will be subject to an administrative fee of \$500 per person.
- No refunds will be issued for cancellations less than 30 days prior to departure.
- You can purchase travel insurance to cover unexpected cancellations. We can recommend sources upon request.

Hajj Package Does Not Include:

- Fees paid to the Unified Agent Office and Visa Processing (\$300 expected Cost).
- Cost of Zabiha / Sacrifice (about \$120).
- Domestic flight cost for USA departure other than Houston.
- Personal wheelchair assistance throughout the Hajj duration (\$1,500 add on)
